Achievements like this require a commitment from everyone.

Despite the introduction of a new focus for 2024 the NUCA S&RM Committee will continue to highlight and pursue safety awareness for trenching and excavating. Afterall....We Dig the Carolinas!!!

During 2024, the S&RM Committee will be emphasizing Work Zone Safety. It goes without saying that many of our co-workers face issues with the people we are working to help. During 2021 it was reported that a combined 36 fatalities occurred in work zones in North and South Carolina. While several reasons can be attributed to these issues, these issues can be helped, and our co-workers can have a safer day on the job.

We will kickoff our meetings in less than a month on Feb. 13th at Pineville United Methodist Church, in Pineville NC. During this meeting we will touch on issues that are being addressed on a state level and opportunities we can take to help keep our folks safe. Going forward we are planning to drill down and look at Work Zone Setup, Worker on Foot, (safety issues inside the work zone), and then wrapping the year with a review. More specifics to follow as we move forward.

I would like to thank all of you for supporting the NUCA S&RM Committee. I would also like to thank Mike Coates / Safety Committee Co-Chair and Linda for their continued efforts for this committee. There is little doubt that with your continued support the S&RM Committee will continue to grow and be a conduit for safety to all our co-workers and their families.

Industry News and Advocacy

Industry Funding Bills Await Congress's Action By Feb. 2

Congress returned for work on January 9 to begin an arduous sprint where the GOP-controlled House and Democrat-controlled Senate must resolve significant differences over transportation and other government funding in a short period of time. Under the two step "laddered" continuing resolution agreement brokered by Speaker Mike Johnson (R-LA-04), the House and Senate have until Jan. 19 to sort out their FY2024 transportation appropriations (T-HUD) differences or else face a partial government shutdown. Remaining funding bills including FY2024 Interior-Environment (EPA SRF resources) have a Feb. 2 deadline, by which point a possible partial government shutdown would turn to a full one. Meanwhile, the beginning of the appropriations process for FY2025 will soon be upon us and NUCA will be there to defend the resources we use to improve this nation's infrastructure.

Other critical deadlines and legislation loom as well. Pipeline Safety and Hazardous Materials Administration (PHMSA) re-authorization under the PIPES Act - and its associated damage prevention language - still lags far behind its previous expiration date of Sept. 30, 2023. And the Senate must act on its version of FAA airport reauthorization (S. 1939) to meet the next authorization deadline set for March 8 (see paragraph below). The Senate bill must first pass out of committee before the full Senate can vote on it, and then face a conference committee to resolve differences. Congress will need to move swiftly to address these key issues before election 2024 begins to pull them away. It will be a busy year on Capitol Hill, and we want you to be part of NUCA's advocacy efforts.

FY2025 Appropriations Process Begins In February

Last year's House cuts to both State Revolving Funds (SRF) in the FY2024 EPA appropriations bill took many water sector organizations and supporters by surprise. This time around, NUCA and other associations plan to be much more aggressive for the FY2025 appropriations cycle. Our outreach to appropriations committee lawmakers and staff has been underway for several months. With your help alerting your lawmakers via our Muster system, NUCA shined a spotlight on how destructive these cuts can be to a community's health and economic growth, and it appears that House leadership recognized their mistake. But working with appropriations—one of the most specialized lobbying functions in Washington—will remain challenging, especially in an election year where lawmakers are reluctant to increase the federal debt or taxation.

<u>Pipeline Reauthorization Bill Passes House T&I Committee</u>

The long-anticipated House action on pipeline reauthorization took place in early December, when the House Transportation and Infrastructure (T&I) Committee passed on Dec. 6 by voice vote the Pipeline Efficiency and Safety (PIPES) Act (H.R. 6494).

<u>NUCA released a statement</u> strongly supporting the PIPES Act. "NUCA in particular endorses the bipartisan proposal to strengthen damage prevention laws, by encouraging and endorsing state implementation of best practices long advocated for by those in the excavation community," said NUCA Chief Executive Officer Doug Carlson. The damage prevention and excavation safety language in the legislation largely aligns with the recommendations made by the Infrastructure Protection Coalition's 2021 Damage Prevention study, which can be found at ipcweb.org. The legislation now moves to the full House for a vote this spring.




