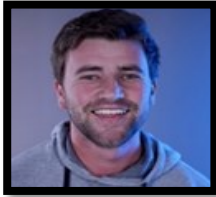

May is here and with it more excavation than you can shake a backhoe at! NC 811 continues to see record numbers of requests, both by professional excavators and homeowners. Full throttle, wide open, no holds barred and any other way you want to state it: we're busy. In March alone we saw a 20% increase over the year prior. April was an 18% over 2020. This means we are already at 9.66% above YTD in 2020. Buckle up because if I had to make an estimation I would not be surprised to see the end of 2021 at 18-20% over the previous year. That jump would reflect an all time record.

On the enforcement front tremendous activity has been underway in the administration. Most significantly the new website www.udprb.nc.gov should be live by the time you read this. Check it out! It includes an explanation of the complaint driven process as well as the ability to create a complaint online using a web form. Additionally the site will contain minutes from previous meetings, a look at who is serving on the Board and their terms and much more.

NC 811 wants to remind everyone of the importance of limiting the number of requests to the work that is actually being done during the 15 full working days. The Locate Resolution Partnership Committee (LRPC) has been actively tracking the multiple update requests, specifically when the work duration is a day or less and the ticket has been "kept alive" for 45 days. Folks this impacts everyone and with the intense fiber installation, infrastructure improvements, DOT projects and a real estate building boom that doesn't show signs of stopping, anything we can do to keep the process running smoothly helps you get your work done safely and with minimal delays.

We have introduced the new "Revise" application! You can use this on your computer or your phone.

Ticket revisions will allow you to:

- Request a destroyed marks ticket for an existing notice,
- Cancel an existing ticket, or
- Request a 3-Hour notice on an existing ticket.

To process the ticket revision, you will need :

- The existing ticket number and the phone number that was provided when the request was made to perform these revisions
